The Trade Marks (Amendment) Rules, 2011

In exercise of the power conferred upon the Minister by section 78 of the Trade

Marks Act, the following Rules are hereby made:-

- These Rules may be cited as the Trade Marks (Amendment) Rules, 2011 and shall be read and construed as one with the Trade Marks Rules, 2001 (hereinafter called the principal Rules).
- 2. The principal Rules are amended by deleting the First Schedule and substituting therefor the following –
