PRIVACY NOTICE

The Jamaica Intellectual Property Office respects the rights to privacy of our customers, employees and other stakeholders and is committed to taking the highest level of care to safeguard all personal data in our possession.

This privacy notice discloses the practices of the Jamaica Intellectual Property Office in accordance with the Data Protection Act, 2020 and defines the following:

- the personal data collected to conduct business with the Office;
- the manner in which the personal data is collected, used, stored, shared and otherwise processed;
- security controls implemented to protect your personal data, and

HOW DO WE GET YOUR PERSONAL DATA?

YOUR RIGHTS REGARDING YOUR PERSONAL DATA

The Jamaica Intellectual Property Office would like to ensure that you are aware of all your data protection rights, while ensuring that only the minimum data required to facilitate our services is captured and used.

You have the following rights under the Data Protection Act, 2020:

- The right to access your personal information you have the right to request from us copies of your personal information that we have collected;
- *The right to rectification* you have the right to request that our company correct any information you believe is inaccurate or complete any information you believe is incomplete;
- **Data portability** you have the right to request that your personal information be transferred to another organisation or directly to you;
- Restriction of processing and objection you have the right to object to the processing of your personal data and to request that our company restrict the processing of your personal data;
- The right to not be subject to automated decision-taking you have the right to object to any processing that results in a decision made about you which includes no human intervention.
